WATERFORD CO. COUNCIL.

UNPAID ANNUITIES

A special meeting of the County Council was held on Friday by Mr. Commissioner Moynihan.

Roadworks Scheme

The Roadworks Scheme which was due for consideration was again adjourned. The Commissioner stated as they had received no information regarding the Agricultural Grant consideration of the Road Works Scheme should be adjourned to a meeting to be held on February 11th.

Financial Position of Council

Total warrant of the Co. Council for the current year £102,322 10s. Amount collected to date £52,305 16s. 3d. Amount outstanding £50,016 13s. 9d. Amount of overdraft £35,820 2s. 1d.

A Grange Road

A deputation consisting of Messrs. Flavin, Fleming and Ryan, of Grange, appeared before the Council in connection with a road at Grange which was in a very bad way and needed repairs.

Mr. Flavin said the road was used by every farmer in the parish. Fr. Synnott, C.C., had written about it. There was a lot of traffic on the road. Some years ago the ganger had a gullet there closed to put in a bigger one, but that was not done, and the road was flooded. People going to Mass had to go across a cottage plot.

He asked that the road be put under contract for 3 years.

Mr. Bowen said the road was always very bad. It was a muddy, putty sort of ground and you could put all the stone of the Mountain on it.

The Commissioner said Mr. Bowen would look into it and he would consider it when the Road Works Scheme came to be dealt with.

Mr. Flavin referred to all the beet that was drawn over the road.

Mr. Moynihan—If you had to ask for a new road for all the roads used for drawing beet you would want a lot.

The Fishermen of Garrarus near Tramore, asked for some place where they could put their boats and said if something were not done they could fish no longer and 6 or 7 families would have to go on the rates or the dole. They asked for a slip or a wall.

Mr. Bowen—We never did anything there. There is no pier or anything at the place.

Mineral Rights

Messrs. Whitney, Moore, and Keller, asked to acquire the mineral rights of the Council in their quarry at Dunabratinn.

Mr. Bowen—We have a quarry of 12 acres at Dunabratinn. These people want their mining rights to go through the whole district. We should give them the mining rights at whatever compensation is fixed for the other people, but we reserve the right to take our road stone down to low water mark. The quarry is on top of a cliff 200 feet high over the sea. We are working on the top.

Mr. Moynihan—If copper were mixed up with the road material we would want to make it clear.

Mr. Bowen—We can take the road stone and they can take the copper if they have it. If we retain the right to quarry stone we will be satisfied.

An order was made referring the matter to the solicitor to give the concession at the same rate of compensation as is paid to other people in the area.

Mr. Moynihan—I hope there will be prosperity in the area as a result of the mining.

The offer of Mr. Power, Doon, to sell a site for a Dipping Tank at the Halfway, for £5 together with payment of £3 17s. solicitor's costs was referred to the Diseases of Animals' Committee.

Unable To Sanction

The Department of L.G. and P.H. wrote stating the Minister was unable to sanction a gratuity to Ed. Power, Caretaker of the Co. Offices on his recent retirement from the position.

Improving Tramore

Mr. Bowen, Co. Surveyor, reported re the widening of approach to Promenade at Tramore, and said the Boys Club Authorities were agreeable to give the necessary land to widen the existing road and also to give sufficient land along the site of the new roadway to make a 75 foot roadway and to remove existing buildings in consideration of the Council building a concrete wall 4' 6" to 5' high and erecting a shed equivalent to the café to be removed. The wall to be built would cost about £90, clearing the site £20 erecting building £30 to £40. He asked for approval for the transfer of the land and for the expenditure of, say, £70 for the wall and preliminary work. He wished the work done before the summer. Mr. Bowen said the Commis-

sioner had had included in his relief proposal recently a sum for this work conditional on getting a grant in aid which was not forthcoming.

Mr. Moynihan approved the Co. Surveyor's report on the matter:

Shandon Road, Etc.

Commissioner—My attention has been called to the awful condition of the Shandon Road and also the old Hospital Road. I have been asked if anything could be done to repair them. These two roads are the responsibility of the Urban Council, but I think the County Council should take action about them. In no circumstances should they be allowed to remain in the condition they are in.

The following order was made—It is hereby resolved that having regard to the bad condition of repair in which certain roads in the Urban District of Dungarvan are allowed to remain, particularly the roads known as the "Shandon Road" and the "Old Hospital Road" the Minister for L.G. and P.H. be hereby requested to make an order under Section 24 of the Local Government Act 1925, directing that the County Council of Waterford is to construct and maintain the said roads as from 1st April 1936, such order not to affect the area of charge for the expenses of such construction or maintenance, and furthermore, that the Minister be requested to make a free grant of 50 per cent. of the cost of re-surfacing these roads and to approve of a long term loan for the remaining portion of the cost.

Unemployment Relief Schemes

The Tourist Association ask Public Bodies and interested persons with a view to relieve unemployment and to be used as a basis of National development in the future to prepare schemes in each area of essential works so that they may have a co-ordinated National scheme which would eventually enhance the attractions of this country.

In addition to widening roads, drainage, bad corners, footpaths, etc., they suggest new roads as important links in the road system or as a means of access to undeveloped national assets.

On many cul-de-sac roads leading to places of parking and turning room for vehicles. There are numerous bathing strands, fishing waters, antiquarian remains, neglected mineral spas, historical sites, etc., to which access should be created for the people combined in some cases with the essential work of preservation. Again at resorts, seaside and inland, not only road improvement, but baths, shelters and modern amenities can be called for.

The Commissioner approved of the memorandum, and commended it to all those interested all over the county.

Popular Lady's Recovery—Mrs. Villiers Stuart, the popular wife of Mr. Ion Villiers Stuart, M.F.H., who had been rather seriously ill for some weeks, has now completely recovered, and her hosts of friends were delighted to see her in town again recently, looking the picture of health and spirits, and quite as gay and charming as ever.

A kind, big-hearted and generous lady, Mrs. Stuart has won a high place in the hearts and affection of all classes of the public in Cappoquin for many years, while as a brilliant sportswoman and an energetic worker in the promotion of all sporting, social and charitable projects in the district, she has few equals in the South of Ireland.

Presentation To Popular Sportsman—At the annual meeting of the Cappoquin Point-to-Point Race Committee, held recently, Mr. L. Villiers Stuart, M.F.H., Chairman, called attention to the fact that one of their most prominent members, Mr. David Kiely, Ballynoe, had been married since their previous meeting, and he proposed that a suitable present be given to him in honour of the auspicious occasion.

This was unanimously agreed to, and in due course Mr. Kiely was made a valuable and appropriate Presentation on behalf of the committee. At a subsequent meeting of the committee, Mr. Kiely suitably thanked the members for their great kindness, and said he wished to specially thank Mr. and Mrs. Villiers Stuart, and also Mr. R. L. Keane and Miss F. Keane, for the kindly interest which they had taken in the matter and for which he was deeply grateful.

Violin Broadcast By Local Artist—Mr. Patrick J. Parker, Villierstown, has been engaged to broadcast a selection of Traditional Irish music on the violin from Cork Station on Friday night Jan. 31st.

This young and promising artist has enjoyed a very high local reputation for a considerable time past owing to his tuneful and musical performance with the violin, and has been in great demand at most of the leading Concerts in West Waterford for a long time. He was specially engaged to play the violin accompaniments for the Champion Irish Stepdancer of Cork at a Concert held in the Irish College, Ring, last month, and was recently given an audition at the Cork Broadcasting Station, where his playing was so perfect that he was promised a wireless engagement in the near future.

GO. WATERFORD VOCATIONAL EDUCATION COMMITTEE.

AN FEAR MOR, Chairman, presided at the monthly meeting of the above on Tuesday. Others present were L. O'Meehan, S. Hayes, S. Curran, and Commissioner Moynihan.

Payments

Mr. Bowen, Architect, certified a payment of £1,500 to the contractors of the New Technical school. Payment was passed.

Salaries

Sums of £280 8s. 2d., salaries of officers and Sundry payments amounting to £240 5s. 8d., were passed.

Co. Council Contribution

A letter from the Department authorising the Committee re the demand for the Annual contribution from the Co. Council for the financial year 1936-37.

The Secretary stated that the amount is £3,140 for the year.

The Department also wrote forwarding a paying order for £1,525 the second instalment of the grant in aid for the current year.

Loans For Technical Schools

A circular letter from the Department regarding application for Loans for Technical schools, advised that in future applications for loans should be applied for, for building and equipping such schools.

The Secretary said that the letter did not apply to them as they confined the loan to building and the equipment would be provided from cash on hands.

Domestic Economy Classes

A letter was read from the Irish Technical Education Association, relative to increased classes in Domestic Economy in Rural Areas, suggesting that the Department of Education be asked to make special grants to provide for Itinerant teachers of Domestic Economy in Rural Areas.

Chairman—Are not our Domestic Economy Teachers teaching in Rural Areas?

Secretary—Yes; but since the start of the Day Vocational Classes at Dungarvan and Cappoquin, the Teachers are not able to get around as much as formerly. Previously, short courses of about six weeks duration were held throughout the County.

On the proposition of Commissioner Moynihan, the suggestion was adopted.

Annual Congress

The Committee adjourned until next meeting the question of appointing two delegates to attend the Annual Congress.

The Committee also decided to discontinue classes relating to Agricultural Lectures and Rural Science, owing to an agreement between the Department of Education and members of the Technical Agricultural Associations.

Certificates To Be Invested

The Chairman suggested that the Committee should issue some sort of certificate that would be recognised to successful students attending Domestic Economy Classes.

The Secretary said they had such certificates ready for this year.

Kilmacothas Technical School

Correspondence between Mr. J. Walsh, Kilmacothas, and the Secretary, dealing with the purchase of the site for the New Technical School, was read. Mr. Walsh stating that he agreed to give the plot for £100 plus any other expenses and ground rent.

It was decided to inform Mr. Walsh that the committee accepts his offer, fee-simple, and are prepared to pay costs of transfer.

CONTAGIOUS ABORTION AND STERILITY IN DAIRY COWS

INTERESTING LECTURE IN DUNGARVAN

ON MONDAY LAST in the Courthouse, Dungarvan, Mr. Nyhan, M.R.C.V.S., delivered an interesting Lecture on the important subject of Contagious Abortion and Sterility in Dairy Cows. Mr. Thomas Flynn, Coolnagour, presided and over 70 Dairy Farmers were present.

The Chairman said the Lecture was one of the greatest concern to the Dairy farmers of the country and introduced the Lecturer. He said Mr. Nyhan, would answer any questions put to him by the audience at the conclusion of the Lecture.

Mr. Nyhan, V.S., having expressed his pleasure at being present and thanked the large audience who had come to hear the Lecture, said Abortion was causing very serious loss and deterioration to breeders of Dairy Stock both as regards milk and calves as a by-product. He would try to show them how that state of affairs could be remedied and kept under control by the co-operation of the stock-breeder, the V.S., and the Laboratory.

Abortion used to be called Contagious Abortion and was supposed to affect only pregnant cows, but since it was discovered that Bulls harboured microbes it has led to an alteration of the name. About 40 years ago Prof. Bange, of Copenhagen, identified the microbe and at the time he and his fellow research-workers thought the time was not far distant when, having found the microbe, they would find the cure for the disease, but the day for the cure had not yet come. To cure the disease you must get rid of the microbes that cause it and they have not yet been successful in doing so. The Abortion microbe cannot live indefinitely in the soil. Under favourable conditions it would live 5 months, but in the presence of sunlight not longer than a week. It is easily destroyed by disinfectants. Only in the pregnant cow it can set up the symptom of Abortion. In the last few years it was found to effect man setting up a recurrent fever similar to the 'Flu and has been only found to effect grown up people, principally males between 30 and 50 years of age and females from 49 to 60 years of age. There are recurrent attacks every few months and they set up similar conditions to Malta Fever, which is contracted from the milk of goats. Other animals on the farm can be infected. It is a disease of sexual maturity. The Lecturer then gave a list of ways in which cattle get infected and showed how the microbe gets into the body, but only pregnant cows can become infected. It had been proved that the bull could be infected and passed the microbe to the cows. The heifers did not become infected the first year, but the following year when let out with other cows were infected. It has been found that infected food is the most frequent way in which the microbes enter the body and the most favourable site is the pregnant womb. The calf in that case would be more liable to diarrhoea and such diseases. When a cow aborts other microbes gain entrance giving rise to inflammation. When a cow has aborted, the only place the microbes can lodge is in the glands of the udder and they may be retained there for a long time. It has been known they remain for 7 years and such a cow will be passing the microbes in her milk but they would not be as strong as in the womb. As to how a farmer was to know whether his cow had aborted or not he said the cattle suspected should be isolated and the place disinfected. In 3 weeks time a sample of the blood should be taken and examined and the Laboratory test would tell whether she had aborted or not. If so, keep the cow isolated for 3 weeks. If she has aborted keep her isolated 3 to 5 weeks until all her discharges have ceased. Give her a chance to get the womb back to normal as much as possible. If you have samples of the blood taken of all your cows and analysed you will know how far your herd is affected, even those affected but brought their full time to calve. The blood test will tell you how far the disease has entered your herd. He advised holding affected cows back from the bull for 8 weeks.

As to sterility, it is due to a microbe of a different kind and is playing havoc with the herds of the country. It sets up early abortion in heifers and cows and is due to a microbe that establishes itself in the genital passages and can be transmitted from the cow to the bull and vice-versa. He advised that farmers keep such heifers and cows from service for 6 or 8 weeks and have them washed with a solution to clean them out and also the bull. Sterility and Abortion were not the same. The majority of the cases of sterility were secondary to abortion. Fifty years ago abortion was unknown and many people believed it was introduced by the Premium Bulls. For centuries contagious abortion has existed in

other countries. They were more susceptible to disease than their fathers as they were living under different conditions. He advocated giving young heifers a chance and letting them run to calve at 3 years when they would be less liable to abort and could resist infection; also to allow 80 days from the time of calving to letting the cow back to the bull.

Mr. O'Dwyer—Can a maiden heifer though not served become affected? Mr. Nyhan—Yes. It has been proved. In reply to the Chairman, he said the bull should be disinfected occasionally with a mild disinfectant.

A number of questions were then put by Mr. John Greene and others to which Mr. Nyhan replied.

On the motion of Mr. Sheridan, seconded by Mr. Dempsey, a vote of thanks was passed to Mr. Nyhan for his lecture to which he suitably replied.

LECTURE AT BALLYDUFF

On Tuesday evening at the Ballyduff N.S., (Kilmeaden) a Lecture on the same subject was delivered by Mr. Nyhan, V.S., at which there was a large attendance of farmers.

WATERFORD CO. BOARD

The Annual Convention of the Waterford County Board was held on Sunday last in the Granville Hotel, Waterford. Chief Supt. Duffy, occupied the Chair, and amongst those present were—De La Salle, Messrs. M. F. Lynch, T. Roycroft, and P. J. Walsh; Dungarvan A.C., Messrs. W. J. Nolan, Martin Curran, and P. J. Walsh; Lismore A. & C. C., J. Barry, David Cullinane; Waterford C. & A.C., Messrs. Liam Gallagher, L. Dunne and G. Dunne.

The minutes of previous meeting having been read and signed, correspondence was dealt with from Cloghernaugh and Dunhill where new clubs were in course of formation. The Chairman in the course of his address, reminded the meeting that in accordance with the rules every athlete and cyclist had to be a registered member of a club, and if those clubs were not affiliated to the Board it would look very bad in case of any dispute. It was up to the athletes to see that their clubs were affiliated. If a number of clubs were properly affiliated the Co. Board would work more smoothly and being self-supported, would not need to ask the public for financial help. He was glad to see a delegation from De La Salle, as the Colleges could do much for the encouragement of athletics in the county. The Hon. Sec. read the following report—During the year 1935 a number of clubs were allowed to lapse with the result that there was no County Board. In any other county this state of affairs might have resulted in disaster, but not so in Co. Waterford. Two new clubs came to life, viz., the Dungarvan Athletic Club and the Waterford Cycling and Athletic Club. These two clubs attracted all that was best in the athletic life of the county. The former attracted all the athletes and cyclists of West Waterford, while the city club did excellent work in Waterford City and district. The result of this enthusiasm was a record season on both road and path. The Waterford club sponsored a Co. Waterford Athletic and Cycling Championship sports at the Gaelic Field, Waterford, by kind permission of the G.A.A., as well as the Munster 25 Miles Cycling Championship on the Waterford-Kilmacothas road. The race attracted a fine entry from the leading cyclists of Cork and Waterford, and was won by Charlie Guest of Lismore, in record time. West Waterford, on the other hand, were not idle. They were represented by the Glenmore Athletic Club in the Irish Junior Cross-Country Championship at Limerick, and during the athletic season many important events were won by the athletes of West and East Waterford. Michael Nagle, of the Christian Brothers Schools, Dungarvan, made a new record as well as winning the Schools and Colleges' 220 Yards Championship at Croke Park. Important victories were also achieved at Cork, Dublin, Kilkenny, Wexford and Clare, etc. The most important victories were gained by Messrs. C. Guest and J. McGrath, at the Munster Championships at Killaloe, and our team was also successful in the Re-lay Race at Wexford Garda Sports, where our team, mostly composed of novices, defeated strong teams from Wexford, Carlow and Kilkenny. With a new Co. Board and the prospect of new athletic and cycling clubs, the year 1936 should beat all records.

The Hon. Sec. said he wished to return his best thanks to his friends in East and West Waterford, who had helped him during the past year, especially Messrs. Leo Dunne and Liam Gallagher and members of the Waterford cycling and athletic club. The trip to Limerick for the Cross-Country Championship had exhausted their funds and were it not for the friends who had placed cars at their disposal it would have been impossible to send our team to Killaloe for the Munster Inter-County Championships. We could only send a skeleton of a team to Killaloe, but we did remarkably well after such a long journey. The

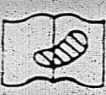

**MR. M. V. O'DONOGHUE,
ELECTED CHAIRMAN**

MANY MATTERS DISCUSSED

EIGHTY-SEVEN Delegates, representing the Gaels of Waterford County and City assembled at the Court-house, Dungarvan on Sunday, for the Annual County Board Convention, under the Chairmanship of Mr. Liam Walsh.

The following members of the County Board also attended—Messrs. M. Connors, V. O'Donoghue, D. Gode, (Western Board); T. Dalton, E. Power, P. Heame, and C. Ware (Eastern Board); Mr. F. Ryan, Chairman, Western Board; W. Lawlor, Chairman Eastern Board; S. Hayes, Treasurer, County Board; and P. Whelan, Secretary, County Board, also attended.

CHAIRMAN'S ADDRESS

Liam Walsh, outgoing Chairman, in an address to the delegates, said:— In his annual report, our County Secretary draws attention to the tardiness with which our County Championships are conducted. For years back it has been customary to stage our finals in the months of October or November, with the result that fixtures which, if played in August or September would attract good patronage, are usually attended by a very sparse gathering. Apart from the matter of patronage, this belated policy of concluding our championships is not always featured with a true reflex of form, because it often happens that a team prepared to meet its obligations early in the year finds it hard to keep its players in training to convenience the late clubs.

The first duty of the incoming County Board should be to definitely fix dates by which county finals should be concluded, and in this matter the whole-hearted co-operation of the Divisional Board is essential; they in turn should fix dates for divisional finals, and should these finals not be concluded in time the defaulting division or divisions should be compelled to nominate teams so that county finals could be finished by the dates specified by the County Board.

Finance And Apathy

A study of the balance sheet will show that our financial position is not in a healthy state. Finance has always been a vexing question in this county, because we have not the patronage of the general public such as the G.A.A. has in the other Munster Counties. In Cork, Clare, Limerick, Kerry and Tipperary, the Gaelic spirit and the traditions of the Gael are healthy and virile. We in Waterford, unfortunately, are in the midst of an indifferent and apathetic population as far as Gaeldom is concerned. In the matter of games and amusements the general public of Waterford—especially those of the city—give their allegiance to imported games and dances and other sports, rather than to the games, dances, and traditions of their own country. In their enthusiasm for the foreign article they trip over each other rushing to the support of the games played by third-rate players imported from cross-Channel. A good many young people claiming to be thorough Irishmen patronise these games; some of them boast they have never witnessed a hurling match, and take pride in the fact that they help to contribute to the wage roll of men imported to play a game for the amusement of a gullible public.

Eradicate The Club Spirit

Another aspect that is not helpful from the financial point of view is that some of our clubs are not broad enough in their outlook; too much energy is devoted to club and too little to the general principles of the Association. Rivalry between clubs is good and healthy, but when guided by a narrow-minded spirit it becomes vicious. It is noticeable in some parts of the county that certain players and patrons of particular clubs never attend fixtures unless their own club happen to be represented in those fixtures. This is not the true spirit of the G.A.A. and it shows an utter lack of co-operation that should be the guiding light of all true members of our organisation. We should remember that our club is but a tiny atom of a huge association. As loyal members of the G.A.A. it should be our duty as well as our pride to attend, when possible, every fixture in our area. If we acted thus our financial position would soon be in a sound state, because if we had the material as well as the moral support of all our members I believe our financial difficulties would solve themselves within a year or two.

The National Aspect

While striving to win honours for our club, county or province, we should not lose sight of things fundamental; we should realise that the winning of games is not the be all and end all of our activities on behalf of the Association. As you are aware, the G.A.A. though non-political in the true and strict sense of the word from its birth in 1884 our Association has ever been in the forefront of any movement aiming at the building up of a free and independent Ireland. The rapid growth of the Gaelic League, Sinn Fein, the Industrial Development Association; and the I.R.A. was brought about through the efforts of men of the G.A.A. In the fight for freedom the men of Gaeldom played their part nobly and well—so well, indeed, that during the Black-and-Tan regime our Association ceased to function in most areas, especially in the South, because

its officials and many of its rank and file were engaged in a more serious game than hurling or football.

Confidence Confirmed

Many of the leaders of the I.R.A. built their hopes on the men of Gaeldom; even in the early days of the Volunteers this was apparent. From an intimate knowledge of Padraig Pearse, Sean Mac Diarmaid, Liam Mellows and other prominent leaders, I knew how they placed reliance on the young men of the G.A.A. Some years before the formation of the Volunteers I was travelling from Limerick to Tralee with Sean Mac Diarmaid and George Clancy, (who was murdered by the Black-and-Tans in 1921). Sean was at that time organising the young men of the country for the battle, which he in his astute vision saw would not be long coming. His hopes then were based on the G.A.A., because, he said, "this grand organisation is guided by national principles, and its ideals and aspirations are founded on Gaelic traditions, and I for one am confident when the time comes the men of the G.A.A. will not be found wanting in their duty to the country." Pearse and Mellows held similar views, and St. Enda's knew no games but those of the Gael. When conniving politicians, under the pretext of fighting for the right of small nations, burst the national Volunteers asunder the men of Gaeldom stood by Pearse and pledged themselves to fight for Ireland, and Ireland alone, and right through the fight for independence the young men of the G.A.A. acted their part as true soldiers of Ireland.

Win Back The Old Spirit

Those of us who were active during that glorious decade, 1911 to 1921, must confess that the intense patriotic fervour which prevailed in those days is not quite so strong at present. This, to a certain extent, is due to the spirit of hatred and revenge engendered during the civil war period. It is sad to see men who fought so bravely shoulder to shoulder against a common foe stoop to such tactics. A better and more Christian policy would be to forgive and forget, and to remember that we have not yet attained that complete independence which was and is our desire.

To restore that high standard of national morals noticeable through the Anglo-Irish war, the men of our Association will and must play a prominent part. What the men of Gaeldom did to create a spirit of loyalty and brotherhood in troubled times they can do again with the help of God. In our quest for national unity it behoves us to pledge our support to every movement aiming at the building up of an Irish Ireland.

Eradicate Parochialism

If only clubs, players and officials would realise and act up to the principles of our Association, we would hear very little of clubism or parochialism. Unfortunately, some clubs imagine that they are a law unto themselves, that they are above and beyond the general rules and regulations of the G.A.A. Such clubs are not a credit to our organisation, and the sooner they realise this fact the better. It is no pleasure to any Council or Board of the G.A.A. to take action of a drastic nature against clubs, but arrogant and domineering conduct must be dealt with in a stern manner in the interest of discipline and regulated order. No club or individual is so important that he cannot be done without. We have been told many a time that Waterford would not be on the hurling map without the assistance of certain players. Recent games in our National Hurling League, however, proved conclusively that our county is by no means deficient in good hurling material.

The Boundary

In his report, Pax refers to the analogous position prevailing regarding boundaries as affecting Waterford County. Ferrybank, as you are all aware, is as much part of Waterford City as is the Quay or Ballybricken; every brick and stone of Ferrybank and all the big business concerns there are part and parcel of Waterford City. The people of Ferrybank pay not a penny rates or taxes in Kilkenny; all these are assessed and collected by the Waterford Corporation. The people of Ferrybank have not even the choice of voting in Kilkenny County; they must vote in Waterford Borough at Dail and municipal elections. The people of Ferrybank, whether they like it or not, are all Waterford citizens. Notwithstanding these hard facts, the Central Council decreed that Ferrybank is in Kilkenny County, because the river Suir cuts between the "village" and Waterford City. The same river Suir divided Carrick-on-Suir from Carrickbeg, yet the Munster Council decreed that Carrickbeg belonged to Tipperary. As Ferrybank and Carrickbeg are parallel cases, either the Central Council or Munster Council must be wrong. Certainly the toss against Waterford cannot be won on lines of "heads I win, tails you lose." Geographically and in other respects we are a weak county, and in the best interests of the G.A.A. it would not be a great sacrifice on the part of two outstanding Gaelic counties like Tipperary and Kilkenny to waive their claims to the two areas concerned. When Ferrybank was affiliated to Waterford Co. Board the village was a force to be reckoned with and was always in a position to field at least four teams; since its transfer to Kilkenny County, Gaelic games have been at a very low ebb in what was once known as the "hurling village." It is to be hoped that Johnny Leahy and Sean Gibbons, will not persist in the Craigavon attitude of not "yielding an inch." The Chairman resumed his seat amidst loud applause.

Balance Sheet

The balance sheet showed a debit of £128 7s. 6d. Mr. O'Donoghue (Lismore) raised the question of the expenses of teams travelling for National League games, and

did not agree that the expenses was necessary, as he felt that the number of players and officials travelling should be reduced to 20 players and one official in respect of National League matches.

The Chairman said that this was the place to raise such questions, and it was up to the delegates to suggest ways and means.

The Secretary explained the difficulty of getting in the players from the different parts of the county and said that the Selection Committee often takes the question of expense in getting certain players into account, and that was a thing that should not happen.

Mr. Gough (Fenore) asked if Fenore were going to get expenses in connection with their re-played match with De La Salle.

The Secretary said it was a matter for the Board, as the bye-law stated that expenses in such cases would be given where funds permitted.

The balance sheet showed that medals were due since 1928.

Mr. P. O'Donnell suggested that clubs should forfeit the medals to help the finances of the Board.

Mr. Hassehy, (Rathgormack) opposed this suggestion, as did also Mr. Lawlor, who said the medals were hard won by the players.

Mr. O'Donnell's suggestion was not adopted.

After some further discussion the balance sheet was adopted unanimously.

The Gaeltacht

Mr. Curran (Clashmore) drew attention to the fact that there was no team affiliated in Ring, Ardmore or Old Parish. He thought that the Board should make a special effort to organise these important centres where big gates would be taken, especially during the summer months.

Insurance Scheme

Mr. Ross (Lismore) voiced dissatisfaction at the insurance scheme for injured players now in operation. Inter-county players, he held, should be insured.

The Secretary stated that the insurance rested with the clubs, and it was up to the clubs themselves to see that the players were insured.

Secretary's Report

A Chairde.—I present herewith to the Annual Convention of the Waterford Gaels my Report, with Statement of Accounts and Balance Sheet for year just concluded. The number of Clubs affiliated to the Board is up to the average of recent years, though there is a slight falling off in the number of teams competing in our Championships.

I find it again necessary to refer to the length of time taken to wind up the different competitions. The Senior Hurling final was played at end of October, Senior and Minor Football finals in November and the Junior Hurling, Junior Football and Minor Hurling have yet to be decided. This is a state of affairs that the Board should at once take steps to remedy as it is not a healthy sign. As I suggested in my report for 1934, definite dates should be fixed for all finals and strictly adhered to. All our games were played in a good sporting spirit and with the exception of some scenes at conclusion of Senior Hurling final, no untoward incidents occurred to mar the progress of the championships.

In Senior Hurling, the League system was abandoned and the competition carried out on knock-out lines, with group teams representing selections of Juniors taking part. Erin's Own again carried off the honours with Tallow as runners-up. The Junior hurling is to be decided between Lismore Portlaw, whose Minors will also contest the minor hurling final against St. Carthage's.

In Senior Football De La Salle were again victorious over Dungarvan. Junior Football brings St. Stephen's and Shlab cGua together as finalists and the Minor football was won by Mountain Rovers with Straalbally as runners-up.

In our Inter-County games all the County teams with the exception of the Junior Hurlers, fared badly and were defeated in their first match. The Junior Hurlers after giving very good displays in their games were defeated in the Munster Final by Limerick, who won the All-Ireland honours.

I must again refer to the low standard of football in the County; discussion and a special meeting to consider this question during the year were unproductive of any constructive suggestions or scheme, for its advancement, as the majority of the football clubs did not take up the task with the enthusiasm necessary for furthering the game. It is to be hoped that the question will be more earnestly taken up by the incoming Board.

The position of hurling is most encouraging, as is shown by the splendid performances of our team in the National League, despite the fact that, owing to the suspension of the County Champions, Erin's Own, the County team at present does not include a member of that Club. As the question of the suspension of this Club is to come before the Board at its next meeting, I will refrain from any comment on the matter beyond regretting that such action should be taken against any Club, and hoping whatever is the outcome a better spirit will prevail when the matter is closed.

In the National Leagues we have only an interest in Hurling as we are not entered in the McGrath Cup. We finished last year's Hurling League at the bottom of the table without a win. In the current competition we have played four games and we have every reason to be proud of the displays of our young team, who though only getting the full points in one of the matches played to date, have been so consistent in their performances that we have every reason to be hopeful of their progress in the future.

Financially we had a very bad year. Receipts from fixtures, our chief revenue, showing a big decrease. Our Receipts from National Hurling League matches to date are £124 11s. 6d., and expenses of same, not including advertising and

other incidentals amount to £182 os. 6d., which leaves a loss of £59 9s. 0d. Last year this competition at the same stage showed a balance in our favour of £16 2s. 8d. Receipts from County matches during the year were £104 8s. 6d. as compared with £120 3s. 1d., in previous year. Expenses of these fixtures in 1934 were £69 4s. 5d., and in the season concluded the expenses of our County Fixtures are £39 14s. 1d. In 1934 it must be remembered that a percentage went to clubs taking part in Hurling League. There remains of course the three finals not yet decided, and the Junior Football semi-final gate at Cappoquin, particulars of which are not available at time of going to Press, to reduce our adverse balance on the year's working, but the fact remains that with our present takings at gates being so low it will be a difficult problem to overtake our liabilities. Our only other sources of revenue are affiliations and Grants from Provincial Council which I have not to record on this occasion as we received none. As regards our ordinary expenditure there is a reduction under most heads, except Trial games, which are a very necessary part of our programme. The whole question of our sources of revenue should be taken up by the Board at first opportunity, and every effort made to effect an improvement.

Selection Committees are again the subject of motions before the Convention, as they affect the working of the Association considerably, and in view of all the discussions arising out of them in the past season it would be well for all Clubs to give them careful consideration. The same applies to all the other motions, which I trust will be considered in the spirit that prompted the Clubs that put them forward, namely the better working of the Association in the County. The motion regarding our boundary deserves the support of all Waterford. A few years ago the Central Council took away Ferrybank and now the Munster Council have decided that Carrickbeg is in Tipperary so the Decies territory is being gradually cut away and definite action must be taken to know what is Waterford.

In conclusion, I thank all fellow-workers in the Gaelic Athletic Association for their valued co-operation and assistance in the past season and expressing the hope that the year before us will bring greater success to the game of the Gael in the County.

The Secretary, in an address, said that something should be done to improve the finances, for at the present system the Board would never overtake their liabilities. Confined as it is at present to affiliation fees and gates of finals. Here in Waterford they had the very same expense as Tipperary or Cork, who can take a £300 gate at a County Final. He paid a compliment to the Waterford Junior Hurlers of 1935, whom he said were a credit to their County. Expenses he said, were kept as low as possible, and as compared with other counties Waterford had spent less.

Election Of Chairman

For the position of Chairman, the fol-

lowing were nominated—Messrs. W. Walsh (outgoing); F. Ryan, Tallow; M. V. O'Donoghue, Lismore and T. Kynce, Dungarvan.

Mr. Ryan having withdrawn, a vote between the remaining three resulted: Mr. Walsh said before proceeding with the poll he would like to have the permission of the Club that nominated him to allow him to withdraw.

A Tallow delegate, as one of the clubs who nominated Mr. Walsh, I would ask him to go forward.

Mr. Lawlor—I put it to the Convention that Mr. Walsh be not allowed to withdraw.

A poll was then taken and the voting was—Walsh, 36; O'Donoghue, 38; Kynce 10.

The result of the second poll between Walsh and O'Donoghue was—Walsh 40; O'Donoghue 45.

Mr. Walsh said he would like to take this opportunity of heartily congratulating Mr. O'Donoghue on his election. He felt it was time for a change, as he had occupied the chair now for 6 or 7 years.

Mr. O'Donoghue, speaking first in Gaelic and later in the Bearla thanked the members for electing him and Mr. Walsh for his congratulatory remarks. He referred to the load of work to be done during the coming year, and the necessity of cutting down expenditure, and said that during the coming year there would be no spoon-feeding of clubs and if any hard knocks are coming to clubs they must be prepared to take them in the proper spirit.

Mr. Walsh was then unanimously made Hon. President of the Association in Waterford on the proposition of Mr. E. Power, seconded by the Chairman and supported unanimously.

Messrs. P. Whelan and S. Hayes (outgoing) were re-elected Secretary and Treasurer respectively.

The Secretary and Mr. Walsh were elected to sit on the Munster Council.

Messrs. Paul Russel, Creigh and Lawlor, were delegated to attend the Munster Convention in Dungarvan.

WATER WORKS IMPROVEMENT HARBOUR BUOY

Mr. M. Morrissey, Chairman, Presided at the meeting of the above held on Friday. Also present—Messrs. T. McCarthy, V.C.; J. Hayes, P. Byrne, P. O'Dwyer, J. Dahill, P. Quann, J. Foley, J. Christopher, J. J. Crotty, M. Clancy.

Harbour Account

In connection with the proposed monthly payments, the Clerk stated that the harbour finances were in a bad state and there was not enough money there to meet the usual payments. The Department had not yet sanctioned the increased dues arranged between the Council and the merchants.

In answer to Mr. Clancy, the Clerk stated that the transfers this year to the Harbour A/c. was £140.

Mr. Christopher said that there should be a good amount of dues this month. The Council lost revenue owing to the delay in sanction of the increased dues.

Clerk—There was a good revenue from artificial manures up to two years ago.

Mr. Clancy said that the Department should have the position explained and be asked to sanction the increase immediately.

Clerk—The Department asked you to fix a maximum rate so that you could decrease if you so liked. You are more or less tied to the merchants. You came to an agreement with them and you cannot go beyond it.

Chairman—The only thing we can do is to ask the Department to sanction the increase and see what difference it will make.

Mr. Clancy—The only import is coal. Mr. Christopher—There is only a small quantity of maize being imported.

Mr. Clancy—It would be very hard to increase the dues on coal.

It was decided to ask the Department to sanction the increased dues immediately.

Loughmore

Complaints about houses needing repair at Loughmore were referred to the Borough Surveyor.

Shandon Road

The Department wrote stating that there was no money available out of relief schemes for the Shandon Road.

Mr. Dahill said that they should ask the Minister to allow them to close the road.

Mr. Clancy—Two farmers using the road came to me and said that in order to have a road they were prepared to give men and horses free to put out stock.

Chairman—We will have to consider this road seriously and at present we can only adjourn the matter to the estimates meeting. Then we will have to give it full consideration.

The matter was adjourned.

Harbour Lights

A communication was received from the Lights Office inquiring into the harbour lights.

Mr. Curran, Harbour Master, said it

was agreed to put the occulting lighted buoy farther inward in place of another buoy which would be put out where the occulting lighted buoy was. This was agreed to after consultation with the captains using the harbour.

Bye Laws

Arising out of a letter from the L.G.D. the question of the adoption of the bye-laws already agreed on was discussed.

The Chairman said that some member should propose the adoption of the bye-laws which would then be sanctioned.

Mr. O'Dwyer said that there was nothing in the bye-laws concerning slaughter-houses that referred to pigs and one man in the town was not granted a licence on account of pig-keeping. The Council had no authority to refuse the licence.

The Chairman said that there was nothing dealing with pig-keeping in the bye-law. It was under some Public Act that these licences were granted.

The adoption of the bye-laws were proposed and seconded and passed.

Messrs. Crotty, Clancy and O'Dwyer, dissenting.

Water Works Improvement

Messrs. Delapp and Waller, Engineers, wrote in connection with the proposed water scheme. They stated that they were satisfied that the Scheme already submitted would be sufficient to supply the needs of the town and also the 30,000 gallons a day said to be required by the new factory. They asked to be given information as to the levels etc. of the factory. They also stated that the scheme as at present could be gone on with and later if additions were necessary they could be carried out. They also referred to the Kiladangan supply.

The B.S. and the S.S.O. were instructed to wait on Mr. Dickens and find out the necessary information in connection with the factory.

It was also agreed to ask Messrs. Delapp and Waller to speed up their final report.

Dump

In connection with the Council's letter to Mr. George Williams, re the purchase of Shandon Marsh. Mr. Williams wrote stating that he would sell the marsh for £400.

The question of the free dump said to be offered by Mr. Dunne was discussed, and it was decided to ascertain before taking further action if the dump offered by Mr. Dunne was available.

St. Patrick's Night

The G.A.A. were granted the use of the Town Hall for a Gaelic night on St. Patrick's Night.

Harbour Buoy

Capt. T. O'Donoghue, appeared before the meeting and said it was essential to the safety of life and property that the Wigan buoy be put out in the harbour.

Mr. Curran, H.M., said that the buoy would be put out as soon as possible. He intended to bring it over to Abbeyside to have it cleaned yesterday and two men had laid the moorings for it. Mr. Hayes then came to him and asked him if he was aware that the two men he had em-

ployed were not U.S.B. men. The two men were said to had the contract of lighting the buoy.

Mr. Clancy—It is in consequence of what Mr. Hayes said that you did not bring the buoy to Abbeyside?

Mr. Curran—It was.

Mr. Clancy said that he was 100 per cent. trades Unionism, but was against any member interfering with an official. It was not Mr. Hayes's business to tell the Harbour Master anything. The old Council got on very well and always backed up the union. Mr. McCarthy, when Secretary never interfered with an official. Mr. Hayes took a big responsibility on himself in interfering, and it is not the first time he interfered, although he denied it and actually made a liar out of me at this Council. When people do things they should stand by them. I will stand by what I say. The Council should take a firm stand and see that none of their officials are interfered with.

Mr. Hayes said that he asked Mr. Curran if he knew that the men were not Union men. He did not stop the men from working.

Mr. Clancy—I said that in consequence of what you said Mr. Curran stopped the men. I stand by that.

Mr. Curran, H.M.—Mr. Hayes did not stop the men. I wanted to wait for the meeting and see where I stood.

Mr. Byrne—If the buoy was to be painted it should be done by now. I saw 680 feet of a ships side painted in four hours.

H.M.—It is a big job and if the buoy had been over there during the recent gales it might have been broken up. I have to wait for favourable weather.

Mr. Quann—This is a serious business we are told that the absence of the buoy is a danger to life and property.

Chairman—We must only have the buoy out as soon as possible.

Mr. Byrne—There are other capable men in the town and they are members of the union. Why was not the buoy given to Carey who salvaged it.

Mr. O'Dwyer—He was paid and was satisfied.

After a discussion it was proposed by Mr. Dwyer and seconded by Mr. Clancy that the matter be left in the hands of the Harbour Master.

The Chairman said that they should not be splitting hairs over a serious thing like that. He would ask that the Council be unanimous.

Mr. McCarthy said that there was no use wasting the whole night and suggested that the resolution be put to a vote.

On a vote there voted for the resolution—Messrs. Dahill, O'Dwyer, Quann, Christopher, J. Foley, J. J. Crotty, M. Clancy and the Chairman—(8)

Against—Messrs. McCarthy, Hayes, Byrne—(3).

DEATH OF REV. FR. ANTHONY CLEARY, O.F.M., CARRICK-ON-SUIR

The death of Very Rev. Fr. Anthony Cleary, O.F.M., which took place at the Friary, Carrickbeg, Carrick-on-Suir, last week is deeply regretted.

The late Fr. Anthony was born in Ballymacally, Co. Clare, seventy-six years ago. He studied classics in the old Diocesan Seminary at Ennis, and in the year 1879 he joined the Franciscan Order. He passed to Rome for his higher studies, and, having read a brilliant course in theology, he was ordained in May, 1885. He continued to live in Rome for some years after ordination, and became a well-known figure in the Eternal City, especially to visitors for whom he acted as a welcome and capable guide. He acquired a perfect knowledge of every classical work in painting and sculpture to be found in church and gallery in the Holy City. This knowledge he readily imparted to all who needed a qualified Cicerone.

His life in Rome at the Irish Franciscan College of St. Isidore's was otherwise secluded, and that fact gave him both time and opportunity to indulge in his ever-eager desire to acquire knowledge on various subjects—a knowledge too, that no one could call superficial, and so the commonplace never held his interest very long. He could be trusted to introduce important items into most of the subjects that came up for discussion. He taught theology to some courses of students in St. Isidore's College.

Father Anthony took his place for some years in the governing body of the Irish Province of the Order. He was three terms Guardian in different houses and a few years ago celebrated the golden jubilee of his profession in the Order.

As a confessor, he was much sought after. His placid, kindly and easily-approaching disposition, united with a prayerful spirit, must have brought peace and consolation to many in spiritual trouble or in physical pain. To his brethren he was a leading light of kindness, charity and observance. All who had the privilege to know him will remember his advice and treasure the memory of his friendship. "May he rest in peace."

Regret in Carrick-on-Suir.

Deep regret has been occasioned by the death of Very Rev. Fr. Anthony Cleary, O.F.M. A scholarly, pious priest, he was greatly beloved by all in this district who had the privilege of knowing him.

The interment took place on Saturday at the Franciscan Church, Carrickbeg, after Office and High Mass.

U.S. WOMAN JAILED FOR KISSING A POLICEMAN

Police Officer Conrad Beedy, New York, over six feet, tall and handsome, was horrified when a plump, middle-aged woman ran up to him in the street, flung her arms round his neck and kissed him. He arrested her and led her to the Bronx Night Court.

"I was walking my beat," he told the magistrate. "When out pops this Mrs. Olga Ferdens, throws her arms round me and gives me a kiss. 'Hey! I said to her 'lay off, will you?' Everybody in the street was looking, and what could I do, your honour. I had to arrest her. She's been annoying me for more than a year."

Turning to the defendant, the magistrate said that the policeman's beauty was apparent, but a married woman like Mrs. Ferdens should keep her dignity and remember that the officer, too was married.

Mrs. Ferdens said she meant no harm. She had been celebrating an anniversary with a little wine and thought she might as well celebrate Leap Year at the same time, so she kissed the policeman.

"I understand your feeling" replied the magistrate, "but I shall have to fine you two dollars (8s.) or two days imprisonment."

Mrs. Ferdens dug into her purse but found only one dollar and fifty cents. She looked at the police officer, who gazed straight ahead. Then she smiled. "All right," she announced. "I'll go to jail. It was worth it."

ROAD ACCIDENT

Damages Awarded Against Well-known Lady Rider

Mrs. Masters, the well-known point-to-point rider and Master of Tipperary Foxhounds, was defendant in an action at Clonmel Circuit Court, when she was sued for damages for alleged negligence in driving a motor car, as a result of which a young man named James Rankin, Irishtown, Clonmel, was injured.

Rankin said that on a night in September, whilst walking on the road, he saw two cyclists collide ahead of him. He went up to assist, and just when he reached them was struck from behind by defendant's motor car.

She kept into the grass margin or her proper side and could not say if Rankin was actually struck at all or not.

Judge Sealy said that he thought Mrs. Masters was at fault. She saw a dangerous state of affairs on the road in front of her but went on and changed her head, as a result of which the accident happened. He gave a decree for £5.

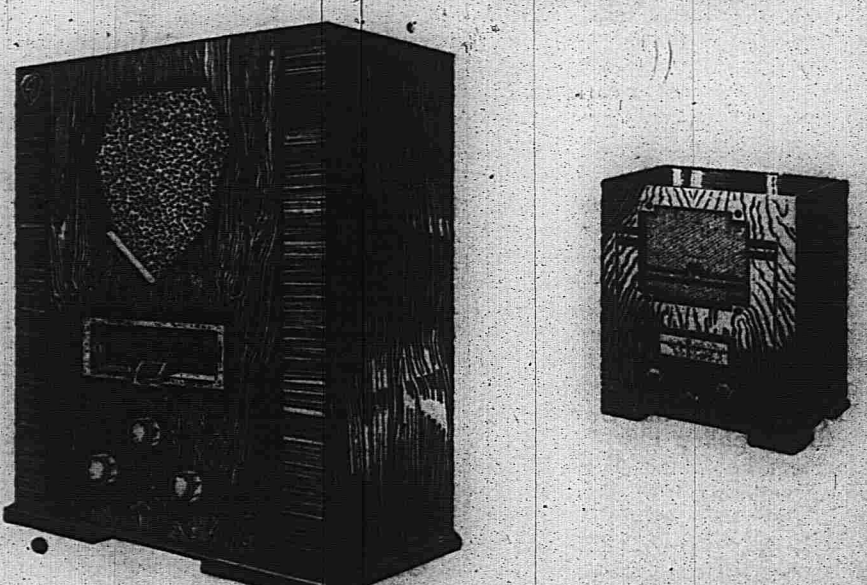

CAPPOQUIN DISTRICT COURT.

(Before Mr. G. P. Farrell, B.L.)

Unlicensed Bulls

The Minister for Lands and Agriculture, summoned James Walsh, Ballymullala, for having an unlicensed bull in his possession.

Mr. E. A. Ryan, State Solr., Dungarvan, who appeared to prosecute, said he should apply for an adjournment in this case, as Mr. T. C. Williams, solr., Dungarvan, who had been engaged for the defence was unable to attend to-day, and the case was accordingly adjourned to the next Court.

Same v. Andrew McGrath, Crinaughtane, Cappoquin, for having an unlicensed bull in his possession on July, 15, 1935.

Mr. E. A. Ryan, State Solr., prosecuted, and defendant was not professionally represented.

Mr. Ryan said the prosecution was brought under the Live Stock Act, 1925, which made it an offence for any person to keep a bull over 12 months old which had not been submitted for inspection and which was not duly registered and licensed.

Sergt. C. Dalton, gave evidence of finding a two-years-old bull in defendant's possession on the date in question which was not licensed. The animal was running with the cows at the time and when he questioned the defendant he said he had got the loan of a registered bull from his brother during the season for his cattle, but this bull had since been returned, and witness believed this statement to be correct.

Defendant now repeated this statement and said the bull found by the Sergt. had been delicate from birth and suffered from Timber Tongue, and that was why he had not got him licensed.

Mr. Ryan—But this is the very class of bull the Department is trying to get rid of in order to improve the quality of livestock.

Defendant said he had since got the animal operated on, and he was now no danger to the cows.

The Justice imposed a fine of 40/- Defendant said he was unable to pay the fine now, and the Justice granted him a month for payment.

Case Under Road Transport Act

The Attorney-General, at the suit of Supt. Quinlan, Lismore, summoned the Blackwater Valley Co-Operative Society, Cappoquin, for an alleged breach of Section 9 of the Road Transport Act, 1933.

Mr. E. A. Ryan, State Solr., prosecuted, and Mr. E. Carroll, solr., Fermoy, defended.

The case for the prosecution was that the defendant's motor lorry was found on September 5th conveying a load of wheat from Cappoquin to Messrs. Shaw's Mills, Cork, for hire, no Merchandise licence having been taken out for the lorry at the time.

The evidence of Guard Moloney, Cappoquin, went to show that on the date in question he found the lorry carrying a load of sacks of wheat, the property of Mr. Michael O'Brien, Farmer, Bewley, Cappoquin, to Shaw's Mills, Cork, without the necessary Merchandise licence.

Mr. Carroll said he had no question to ask the Guard.

Michael O'Brien, Bewley, in reply to Mr. Ryan, said he had a quantity of wheat for sale last August which was purchased from him by Mr. Gunning, Manager of the Blackwater Valley Co-Operative Society, at the standard price of 23/6 per barrel. He had an idea at the time that the wheat was to be sent to Shaw's, Cork, but there was no deduction made from him for the transport of the wheat to Cork.

To Mr. Carroll—It was to Mr. Gunning, Manager, that he had sold the wheat, and it was he paid him for it.

Mr. James O'Sullivan, Secretary, St. John's Mills, Cork, examined by Mr. Ryan, said his company had made an agreement with Mr. Gunning on August 24th, under which they were to pay 8/0 per ton for the carriage of all wheat sent by Mr. Gunning together with 6d. per ton commission. His company dealt directly with the farmers and paid the statutory price of 23/6 per barrel, and paid the same price to Mr. Gunning, plus his commission. They reserved the right to reject any wheat not up to the standard in quality.

Mr. Thomas Gunning, Manager of the defendant company, examined by Mr. Carroll, stated that his company bought the wheat on their own responsibility, and not in the capacity as Agents for Shaws. It was quite open to Shaws to reject any wheat sent by them, and on one occasion they had refused to accept 300 barrels owing to excessive moisture, as they had no drying machinery, and he had afterwards to sell it to the Cork Milling Co., who had the necessary drying machinery. The wheat which their lorry was conveying to Cork on Sept. 5th, had been purchased a fortnight previously by him, and it was so good that he had intended keeping some of it for seed, but he found he hadn't sufficient room for it. That wheat was absolutely the property of the Co-Operative Company and was conveyed to Cork by their own lorry, Mr. O'Brien having nothing to do with the cost of transport of same.

Having heard further evidence, Mr. Carroll asked for a dismissal.

Mr. Ryan having replied,

The Justice said on the facts as proved by Mr. Gunning, he should hold that the Co-Operative Co., had become the absolute owners of the wheat in question and were not, therefore, conveying it for hire on the occasion, so he felt bound to dismiss the case.

Factory and Workshops Act

A case at the suit of the Minister for Industry and Commerce against a local trader for an alleged breach of the Factory and Workshops Act, was adjourned

CATTLE INJURED BY MOTOR CAR

Interesting Case in Cappoquin

At Cappoquin District Court before Mr. G. P. Farrell, B.L., Superintendent Quinlan, Lismore, summoned a young man named John Power, Knockanore, for dangerously driving a motor car on the main road between Dungarvan and Cappoquin on November 19th, 1935.

Mr. J. W. O'Gorman, solr., Lismore, defended.

Thomas Scanlan, Farmer, Coolaneen, Cappoquin, examined by the Supt. stated that on the evening of Nov. 19th, at about 5 o'clock, he and his son, Thomas, were driving 10 cows out from their yard to a field near Coolaneen Cross in the direction of Dungarvan.

Witness went ahead of the cattle to open the gate leading into the field, six of the cows being then ready to go in, while the remaining thirteen were some distance behind, with his son walking behind them. As witness was about to open the gate he looked towards the Cross and saw the lights of a motor car approaching from the direction of Dungarvan. He then raised his stick and shouted to the driver of the car to be careful, as there were cows on the road, but the driver paid no heed, and the car dashed into the cows, injuring two of them—knocking a horn off one, and destroying the hoof of another.

The motor car slowed down for a short time, but went off at a fast pace again, and ran into a third cow which was further back the road in charge of his son. This cow was knocked down right in front of the motor which had to stop then, and his son then went over and spoke to the driver.

Witness was about 150 yards away when the third cow was run into, but he clearly saw the accident by the light of the car's head lamps.

Cross-examined by Mr. O'Gorman—I put it to you, Mr. Scanlan, that it was at 6 o'clock in the evening the accident happened and that it was quite dark at the time?

Witness (amidst laughter)—and I put it to you that it was not at 6 o'clock but at 5 o'clock, and it was not quite dark at the time, only "duskish."

Replying to further question, he said the cows were not scattered across the road, but were coming in a line, and asked Mr. O'Gorman—"Did you ever see ducks coming from a stream in the evening?" (laughter). The cows were travelling like that.

Witness admitted that he had no lantern or light to show that the cows were on the road, as cattle do not like to have any such light around them.

Did you hear the driver of the car applying his brakes, and see the car skidding into the cows?

Witness—I heard no brakes applied and did not see the car skidding, as it came straight into the cattle.

Thomas Scanlan, Junr., in reply to the Supt. said he was driving out the 10 cows with his father on the evening in question at about 5 o'clock, his father being in front of the cattle about 130 or 140 yards in front of him. He saw a motor car approaching from the direction of Dungarvan and heard a crash, and after that the car increased its speed and ran into the third cow at his end.

This cow was knocked down in front of the motor, so that the car had to stop and witness then went over and found that the defendant was the driver, and there were two ladies in the car, one of whom said to him that the cows were all over the road and that the accident could not have been avoided.

Witness then got the name of the driver, and took the number of the car and later reported the matter to the Guards.

Cross-examined by Mr. O'Gorman—He denied that the cows were scattered all over the road, as they were going over the same road every day and always went in a single line, through force of habit.

Sergt. C. Dalton, Villierstown, who was stationed in Cappoquin at the time, said that on the matter being reported to him he visited the scene of the accident next morning, and now produced a sketch of the place where it had occurred.

He saw two patches of broken glass on the road, 120 yards apart, the road being 27 feet wide at this point. The glass was 12 feet from the left-hand side of the road coming from the Dungarvan direction and 15 feet from the right-hand side. Three cows were pointed out to him by Mr. Scanlan, all of which appeared to have been suffering from some injuries.

Supt.—Did you see any marks of skidding near the scene of the accident?

Witness—No; I only saw the broken glass, which showed that the car had been travelling on its proper side.

To Mr. O'Gorman—The glass he saw on the road was like the glass of a head lamp, as it was corrugated glass. He didn't see the car at all, but from his observations it appeared to have been travelling on its own side of the road.

This closed the case for the prosecution, and John Power, defendant, was

to the next Court on the application of Mr. E. A. Ryan, State Solr., who appeared for the complainant.

Presentation To Guard

The Justice said he had been asked by the All-Ireland Donkey Protection Society, to present their Vellum Certificate and a Walking Stick to Guard James L. Harte, Villierstown, in recognition of his efficient services in detecting cases of cruelty to donkeys, and he congratulated the Guard on this special mark of recognition on the part of the Society.

Guard Harte had been twice previously the recipient of similar presentations from the Society in Thurles and Cahir, respectively, and he now suitably acknowledged the latest presentation at the hands of the District Justice.

then examined by Mr. O'Gorman, and said he had been 4 years driving a car. On the evening in question he was returning from Waterford with his sister and another lady in the car, and on coming to Coolaneen Cross he saw a number of cattle on the road and immediately applied his brakes. The car then stopped, owing to the greasy state of the road, as it had been raining all the earlier part of the day. He did not see the cows until he was only about 20 yards away and did all he could to avoid a collision with them. He made no attempt to drive away after the first accident, but in the second case one of the cows walked across in front of the car, and he could not avoid striking her. He gave his name and the number of his car to young Scanlan, and told him he would report the matter to the Guards.

Supt.—Why didn't you report the matter to the Guards at Cappoquin?

Defendant—I reported it to the Guards at Killenagh.

Supt.—Yes; but you were passing by the Cappoquin barrack on your way home, and should have reported the matter there.

Replying to further question, he said he was driving carefully on his proper side of the road, and he denied that he had tried to drive away after the first accident. As a result of the two collisions the front right-hand mudguard and front right-hand lamp were damaged, and the left-hand mudguard was slightly dented.

Miss Philomena Power, sister of the defendant, who was in the car on the occasion, was next examined by Mr. O'Gorman, and said she was the owner of the car and had 9 years experience as a driver. She said it had been raining all day on November 19th, and the night was dark and foggy, with the road very greasy and slippery after the rain. When they saw the cattle scattered across the road her brother at once applied the brakes and took all possible precautions to avoid an accident, but the car skidded into them and the accident was unavoidable.

In reply to the Justice, she said the reason she was not driving was because she was very tired, as she had been out all day and besides, her brother is regarded as one of the best drivers in the district.

Witness having been briefly cross-examined by the Superintendent, Mr. O'Gorman commented on the great danger of driving cattle along the roads on a dark night without any light, and submitted that his client was not responsible for the accident, as he had done everything that was possible to avoid it.

The Justice said Mr. O'Gorman's point about the necessity of having a light with cattle on the road at night may be justifiable, as people driving cattle at night were in the same position as an unlighted car driving in the dark. However, there was no law to compel such people to carry a light, and they had it stated that cattle did not like to have any light about them. On all the evidence he was satisfied that the defendant in this case did not exercise proper care in the driving of his car on the night in question and he should, therefore, impose on him a fine of 20/-.

GOOD MANNERS IN DOGS

An Asset and a Pleasure

WELL-MANERED dogs are a source of pride and pleasure to their owners, as well as the envy of those who are less fortunate. They also have a joy in life that seems to be denied to the more wilful. The spoilt dog that is allowed to have his own way and is humoured in every whim, does not become so attached to his master or mistress. He has not the happiness that comes from service.

The other night I saw a pleasant little incident as I left the station on my way home. A girl was waiting outside with her terrier which was all expectancy, knowing that his master was to arrive by that train. Every one who passed out of the gate was scrutinised with anxiety and when the right man came the delight of the little dog was unbounded. When his demonstrations of affection had subsided, he took the evening paper from his master's hand and with it in his mouth trotted quietly behind the couple, wriggling his body all over since he had been deprived of a part of his tail and could not waggle it as most dogs do.

My own Alsatian gives me an equally enthusiastic welcome when I reach home. Before I get there he is lying at the door with his ears cocked, listening for every sound. In the evening he watches our movements, and if he catches our eye his tail thumps on the floor, telling us as plainly as possible the devotion he feels for us. Now that we live at an hotel his courtesy is extended to the other residents and he makes a point of greeting everyone who comes into the room, even a stranger. Some people are nervous of Alsatians and occasionally a newcomer will shrink back as he approaches them. A lady reassured one of them the other night. "You need not mind Ben," she said, "for he is a perfect gentleman, and he is only welcoming you."

The will to obedience, no doubt, is more innate in some dogs than others though practically all are capable of being taught. A notable example of what can be accomplished by patience is afforded by a famous Alsatian and show Labrador, Dual Champion Danchory Bolo, which was the property of Lorna Countess Howe. Lady Howe's first Lab-

rador was named Scandal of Glyn. He sired one large litter that contained only one dog, and on his death Lady Howe was anxious to get this dog. On making enquiries about him she found that he had been given away because he was so wild and incapable of being trained. The man who had him was only too anxious to get rid of him and there was no doubt when he came to Lady Howe that he was thoroughly tractable. It took her a long time to become on friendly terms with him and longer still to teach him manners and his work in the field, but eventually she succeeded and no more devoted companion could have been desired. He became an accomplished worker, earning his championship at field trials and he was so good looking that he also received his show championship.

Few dogs are past praying for if one only knows how to set about reforming them. Usually, a quiet manner answers the best, but one must find out by studying the temperament of the animal, the most satisfactory method of dealing with him.

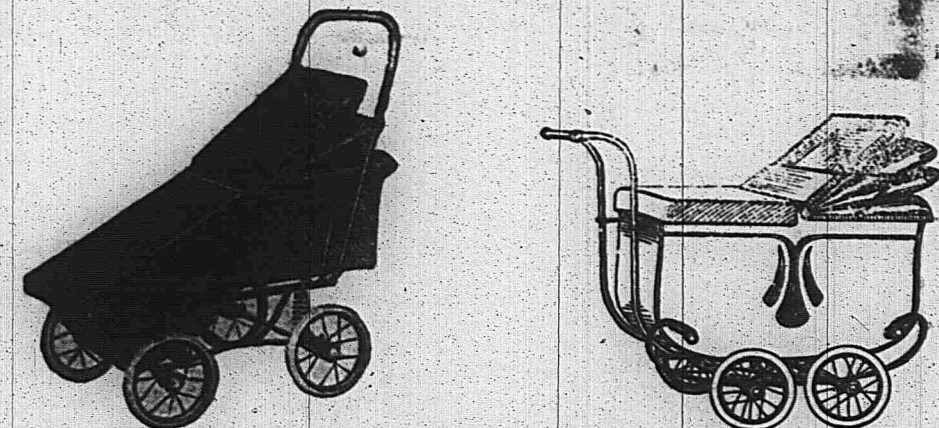

Present—Messrs. P. J. O'Gorman, P.C., Chairman, M. Cashman, W. O'Sullivan, T. Beausang, E. P. Lynch, J. Daly, B.E., R. Power, T. K. Keane, solr., J. N. R. Macnamara, solr., M. Ahern, J. Whelan, J. Forrest, M. D. Broderick, R. C. Farrell, Vice-Chairman.

Another Cinema

Mr. R. Hurst, applied for a licence for a new cinema in Friar street. Mr. Broderick, proposed, and Mr. Beausang, seconded, that it be granted. The Clerk said Mr. Hurst had already been granted a licence, it was assumed and the cinema being erected. He suggested they could not issue a licence for something not there.

Mr. Keane—What does he want it for? The Chairman said that Messrs. Hurst Atkins and Horgan Bros., had been already granted renewals of their licences. It was now assumed that Mr. Hurst wanted a licence for the one that had been burned down.

Mr. Keane—He wants two licences. Mr. Hurst and his manager were called in and the former said he had got a licence a fortnight ago for the new hall. He now applied for a licence for the old hall.

The Chairman—Then you intend to have a new cinema? Mr. Hurst—Absolutely.

On the proposition of Mr. Broderick, seconded by Mr. Lynch, the application was granted, provided the plans were approved by the Town Surveyor.

Dances

Applications for the hall for the dances were received and granted, where the hall was not otherwise engaged.

Mr. Daly said regarding the complaint that persons under 18 years had attended the last Fianna Eireann dance, that one young lad slipped in near the end, unknown to those in charge. It would not occur again.

Gaelic League

An application from the Gaelic League for the Town Hall on St. Patrick's Night to hold a Concert and Ceilidhe was granted.

Acknowledgments

Letters of acknowledgment of votes of sympathy were received from Mr. W. Nunn, Mrs. M. J. Galvin, Mr. M. and Mrs. Bransfield and Mrs. O'Mahony, Ballynoe.

Housing Questions

The meeting was engaged for a considerable time in dealing with applications for new houses, and the Clerk in reply to Mr. Power, said that a general survey of houses in bad repair would be carried out at an early date.

Mr. Power—What about the new scheme? The Clerk—No reply yet. Mr. Broderick—On the question of 3 or 4-roomed houses? The Clerk—No.

It was decided to write again as the Council were desirous to start as soon as possible.

Want Of Civic Spirit

The Clerk reported that they had set a number of lime trees lately, and some had been damaged. The Chairman said they were endeavouring to beautify the place and yet some persons were mean and low enough to do that kind of damage.

Mr. Whelan—There is a great lack of civic spirit amongst us. Call the attention of the Guards. The Chairman—If any of the culprits are detected, we shall make an example of them.

Mr. Power—There is a great change for the worse in the youth of the country. Mr. Macnamara—There is such a lack of civic spirit that I doubt if persons seeing the mischief done would report it.

The Chairman said in other places public property was looked upon as almost sacred and never interfered with. Mr. Power—The cinemas have demoralised the youth.

River Pollution

A letter was read from the Department of Scientific Research, Liverpool, acknowledging the receipt of particulars regarding the river Blackwater and stating that they intended sending over a party to obtain samples from the river and others, with a view to examine the effects of pollution from Creameries, etc.

Mr. Daly said if they Co-operated with the Free State Authorities of the Department of Fisheries some valuable information might be obtained regarding the effects of pollution on salmon fry, etc.

Mr. Whelan raised the question of an earlier opening of the salmon fishing season. Mr. Power said if the season opened a fortnight earlier it would be a boon to the local fishermen.

On the suggestion of Mr. Daly, it was decided to ask the opinion of their colleague, Mr. Murphy, member of the Board of Fishery Conservators.

The General Manager of the Irish Tourist Association wrote thanking the Council for allocating a sum of £20 in their coming estimate towards the objects of the Association.

Sympathy

Mr. Broderick proposed a vote of sympathy with the Rev. Mother and Community of Sister Conception, and also with their esteemed Curate, Father Carey—brother of the deceased religieuse—and other relatives. She had laboured zealously in Youghal for many years, and her loss would be very keenly felt.

The proposition was seconded by Mr. Whelan, and was joined in by Messrs. Keane, Cashman, Daly, Lynch and others. The Chairman said they all associated

CIVIL BILLS

Decrees were granted in a number of civil bills in which Messrs. T. K. Keane, and J. N. R. Macnamara, solr., appeared for plaintiffs.

Jennings v. Rooney

This was an application for an Examination Order. Mr. Keane for plaintiff.

The application was granted.

Tinkers and Hawkers Row

The Court was occupied for a considerable time hearing several charges of assault and cross cases between a local family of tinkers and a number of travelling hawkers. The evidence, which was directly contradictory, included an alleged attack on the house of a Mrs. Hogan and her daughter, Mrs. Ahearn. The old lady stated that the visitors came along and without provocation broke the windows and doors, did other damage, gave her a black eye and hit her under the heart. The daughter stated that she was struck in the face and her teeth loosened. On the other side (for which Mr. Macnamara, appeared) the tale was that they were passing by the house when they were attacked. Stones, bricks and bottles were flying during the melee.

The Justice said he was satisfied that the Hogs were the cause of all that trouble. He wasn't going to try to find the original cause—it would be attempting the impossible. The evidence on both sides teemed with exaggeration. Mrs. Hogan and her daughter were bound to the peace in the sum of £5, and the other cases were dismissed.

Motor Horn Case

Guard P. J. O'Connor, charged Stephen Clifford, farmer, with not having the horn of his motor car in working order.

Complainant stated that the defendant drove into South Abbey without sounding his horn at a time when the children were coming out from the Presentation Convent School. The case was under the new Act, and defendant was liable to a fine not exceeding £10. He was fined 20/- as he did not bother his head to appear.

School Case

Guard Ceasor, charged Wm. Corbett, pensioner, with the non-attendance of his child at school.

Complainant said the child was absent 22 days out of 22.

He was fined 5/-, the Justice saying he would increase it for a further offence.

Improper Tyres

Alexander Fitzgerald, tractor owner, was charged with not having his wheels not properly tyred.

Supt. Kelly, prosecuted. Sergt. Eddie and Guard Smyth, stated that the distance between the grips was 10 inches outside of 3.

Mr. D. O'Flynn, Deputy Co. Surveyor, gave details of the complaint and of the damage done to the road, which he estimated at £2 15s. od.

Defendant said he did not know anything about the law and he did not think he was doing any damage.

The Superintendent said the case was brought to put a stop to the practice. Defendant and his brother were also charged with having no drivers licence. They were fined 5/- in all, with 15/- expenses.

Larcenies

A young man named John Kennedy, was charged with the larceny of a cycle lamp, the property of J. Coleman.

Supt. Kelly, prosecuted. From the evidence it appeared that defendant and Coleman were together, the latter having a lamp. Defendant left for home first and fearing he might be met by the Guards he took the lamp, as he said on the "Compulse of the moment." He was ashamed to return it.

Defendant pleaded guilty and was let out on his own recognisances.

Bridget Walsh, Lagile, was charged with the larceny of a pair of gloves, value 2/-, the property of Nora Fitzgerald, from the Killeagh Dance Hall.

Mr. T. K. Keane, solr., defended. Evidence having been given by Sergt. Eddie to finding the gloves with defendant.

Mr. Keane said they took the gloves by mistake and intended returning them at the following dance.

Evidence to this effect having been given by defendant.

The Justice said the things having been taken by mistake, it was not larceny, but he hoped the case would prove a warning to people against removing articles from cloakrooms.

The case was dismissed.

At the same time he would like to pay a well-deserved compliment to Mr. Leo Whelan, who had discharged the duties for the past five months. The past year was a great success for the Society from every point of view. There was a substantial increase in membership, while the admirable spirit of good fellowship which had hitherto prevailed amongst them, was as firm as ever. They were all delighted with the restarting of the Dramatic Class and they wished it every success. Once again he had the pleasure of complimenting their old friend and caretaker, Capt. P. TALLOW DISTRICT COURT

(Before Mr. G. P. Farrell, D.J.)

SHEEP SCAB

Thomas Hurley, sent., Gortnaphira, was charged with having ten sheep suffering from disease, and with not notifying the Civic Guards.

Supt. Quinlan, Lismore, prosecuted, and Mr. Wm. R. Hodnett, solr., defended.

John Hegarty, Inch, Dipping Inspector, stated that defendant brought a number of sheep on September 5th and 7th to the Dipping Station at Glenacoghara. Witness thought some of them were suffering from scab, and he reported the matter to Dr. Walsh.

Cross-examined by Mr. Hodnett, he said he had sent the original of the notice served on defendant to the Co. Council.

Mr. J. J. Walsh, M.R.C.V.S., Inspector for No. 1 Youghal Rural Council, stated that Hegarty and he visited defendant's farm at Lacken on 7th Sept. He found ten sheep affected with scab.

Mr. Hodnett said defendant was a very old man. At the time his son who looked after the sheep was laid up. His wife was also laid up and she died. Matters were therefore neglected.

Evidence to this effect was given by Thomas Hurley, Junr.

Mr. Hodnett said he had been instructed only that morning.

The Justice—If people don't instruct their solicitors in time they must take the consequences.

Defendant was fined 20/- with £2 12s. od., expenses on the charge of having the sheep affected.

Waters v. Flynn

This was an application by Dr. E. W. and Annie M. Waters, to have a standard rent fixed in the case of Michael Flynn, Barrack street, Tallow, tailor.

Mr. E. Carroll, solr., Fermoy, for applicant, and Mr. Hodnett, solr., Youghal for respondent.

Mr. Carroll said Flynn took the premises on 12th March, 1932, agreeing to pay £2 1s. od. per month, do repairs and pay rates. The tenant complained that the rent was excessive. The P. L. V. was £7 10s. od. The premises were in a leading place in the town and used for the tailoring business.

D. C. Evans, of Lismore Estates Co. stated that on 3rd August '14, there were 5 years of the lease to run. The ground rent on that an the adjoining house being £5 13s. 10d.

Mr. Justin Condon, Auctioneer and Valuer, Youghal, stated he had considerable experience of the district. He estimated that a fair rent for the premises on 3rd August '14, would be £15.

Cross-examined by Mr. Hodnett—He noticed the adjoining house. They were somewhat similar, but Flynn's house was the better of the two. He wouldn't be surprised to hear that the rent of the adjoining houses was 2/6 weekly, as he couldn't tell how it rose. Dr. Waters had bought the Duke of Devonshire's property in Tallow. He didn't know how the Dr. had assessed his rents. The Duke had consulted witness regarding the rentals in the town. He had made a comparison between the two houses. The sanitary arrangements were very primitive.

Mr. Hodnett said he was instructed that that was the most highly-rented house in the town—the average rent being about £12, so that the landlord was asking double the average.

The Justice said he would like to know the figure in 1914, if the tenant had to do the repairs and pay the rates.

Mr. Condon said the repairs might reasonably cost £3 of the £4 yearly.

Mr. Conway, agent for Dr. Waters, having stated that the site was the best in the town, gave details of the house and outbuildings. It wasn't the intention that the tenant should do the repairs. Witness had repairs done to the house since the tenancy.

Cross-examined by Mr. Hodnett, witness said it wasn't the dearest house in Tallow. Some houses were let at ridiculously small rents. The question of average rent would depend on circumstances.

The Justice—The average would not govern a particular case.

The house next door was nearly a "sister" house. They were only accepting the rent of that on account, pending a settlement.

Mr. Hodnett—In 1914 the rent of both houses was £5 13s. 10d.

The Justice—Before we settle the question of rent, I fear we will be smoked out of this place (laughter).

Mr. Hodnett—We say this is a grossly excessive rent. The rent in 1914 ought to be £9 or £10 at the outside.

Mr. Hodnett's client who is deaf and dumb, was then called up and in answer to a written question, wrote down that he considered a fair rent in 1914, the tenant doing repairs and paying rates would be £12.

The Justice thereupon fixed a standard rent at £12.

Lorry Case

Mr. S. Moynihan, Commissioner for Co. Waterford, summoned Anne and James Henley, Tallow, with not producing a lorry to be weighed as required.

Mr. M. M. Halley, solr., Waterford for complainant.

Mr. W. Hayes, Taxation Officer, stated that notices had been served on defendants to bring their lorry to Dungarvan to be weighed, but they did not comply.

James Henley, said that the Railway Co., were taking over the lorry at the time and they didn't think it necessary to have them weighed.

Replying to the Justice, Henley refused to be sworn.

The Justice—I will draw my own conclusion from your refusal. If you want to tell the truth, there is no reason why you should not be sworn.

A fine of 5/- with 5/- costs was imposed in each case.

Ad Interim Transfer. Mr. E. A. Rice, solr., Fermoy, applied on behalf of Timothy O'Mahony, Ballynoe, for an ad interim transfer of the license held by his late father, Mr. P. O'Mahony.

There being no objection the application was granted.

Larcenies From P.P.'s House. A young man named Bartholomew Hickey, Knockanore, was charged with breaking into the house of Rev. Father Morrissey, P.P., and with stealing therefrom (1) on 23rd December, £8; (2) on 29th December, £2 7s. 3d.; (3) on 3rd January, 30/- and (4) on 5th January, £2 18s. 6d.

Supt. Quinlan, Lismore, prosecuted, and Mr. J. W. O'Gorman, solr., Lismore appeared for accused.

Fr. Morrissey, stated he was administrator of the parish, and lived in the P.P.'s house. In the drawing room was a desk in which various monies, personal, charitable and parish were kept. Towards the end of November, he observed that there had been some tampering with the monies. About Christmas he had £10 for charity in one box, and when he looked at it later, he found only £2 left. On the Monday before Xmas he went to Lismore, the housekeeper travelling with him leaving the house and everything locked up. He passed the accused on the road about 300 yards from the house, when they returned everything seemed to be the same as he left it. On Sunday 29th December, he left to say the 9.30 Mass, at which the housekeeper attended. When he returned he found about £2 10s. missing. He then made up his mind finally that the money was being taken. He had some money set aside for petty cash payments and he could not understand how it had gone so quickly. On Friday 3rd Jan., after returning from Mass he found that the money in the desk had again been interfered with he couldn't say how much had been taken. He next counted the notes, took the numbers and marked them, together with two half-crowns, which he marked with blue pencil. He thereupon went to Lismore and reported the matter to Superintendent Quinlan. On Sunday 5th January by prior arrangement he left the house to say the 9 o'clock Mass, Guard Houlihan being concealed in the house, which was locked up as usual. On his return he found the Guard with the accused. The Guard said "we have got the man." In answer to the Guard, the accused produced £2 18s. 6d., which he identified as the money he had marked.

Questioned, accused said he found the key of the room under the mat, and the key of the bookcase opened the desk. Witness hadn't known that it would.

The Supt.—He knew more about the place than yourself? Evidently he knew the run of the house before I came. I

would say from £12 to £15, more or less, had been taken. It was going before I took notice of it.

To Mr. O'Gorman—The accused was a topping workman. He wasn't physically strong. He had a wife and two young children. He gave back £4 and promised to restore the rest. I don't want to press the case at all. I leave it to the Justice.

Mr. O'Gorman said they admitted £12 and two farmers would guarantee that he would pay the balance.

Guard Houlihan stated that while concealed in the pantry on the morning of the 5th, he heard somebody come in the kitchen door and proceed to the drawing room, the door of which he unlocked. Witness then came out and met accused on his way back. He said he had come to see Fr. Morrissey about his insurance cards. When challenged, he produced £2 18s. 6d. Witness then charged him with the various offences and he said "Yes."

Mr. O'Gorman—I must compliment the Superintendent and the Guard on their smart capture.

The Supt. said that was a particularly mean and despicable type of crime of which the authorities took a very serious view and they had instructed him to press for the maximum penalty. That man had stooped to steal from the charity box even, leaving it practically empty.

The Justice said the accused deserved every day of the 6 months he could impose, and if returned for trial he might get even more. However, in view of the fact that Father Morrissey did not wish to press the case that the accused wasn't in good health and that he was a married man with a young family, he was disposed to give him a chance, provided the balance of £8 was made good. He warned persons tempted to crimes of the kind that it was not enough to restore the money stolen. Leniency could be easily overdone, and he was inclined to take a very different course for the future.

Mr. O'Gorman said he appreciated the leniency of the Court. They were throwing themselves on the mercy of the Justice and the P.P.

Accused was convicted and let out on bail, himself in £20 and two sureties of £10 each, two farmers signing a guarantee for the repayment of the £8 balance.

The Value of Nominations to Thoroughbred and Irish Draught Stallions shall be £3 and to half-bred Stallions £2.

Preference will be given to the best Young Mares under six years of age.

Each Mare must be the property of a Farmer, the Tenement Valuation of whose Holding or Holdings, wherever situated and for which he is rated does not exceed £200.

As far as possible two-thirds of the Nominations shall be reserved for Farmers valued at £50 or under. The term "Farmer" is to be understood to mean a person who derives his means of living mainly from Farming.

Special attention is directed to the following Regulations:—

1. Only such Farmers as are rated for Holdings within the County are eligible to exhibit Mares.

N.B.—(This Regulation does not apply to Herds).

2. Each qualified Rated Farmer is entitled to compete for a Nomination for One Mare only, but the Committee may award a Second Nomination to Owners of Mares on the Reserved List.

3. Special Notice—Any person found (a) exhibiting a Mare not his Bona Fide Property; (b) attempting to obtain more than One Nomination through any misrepresentation as to the Ownership of his Mares; or (c) sending for service a Mare other than the one in respect of which the Nomination was awarded, is guilty of a Criminal Offence, and will be prosecuted.

The Committee shall not select any applicant who has an undischarged liability to the Co. Council on foot of rates for the financial year ended 31st, March, 1935.
